- 9. Bids will be opened as per date/time as mentioned in the **Tender Critical Date Sheet.**
- 10. In case of the supplier/firm not supplying the item/equipment after awarding the Contract within the stipulated time period, the EMD will be forfeited and the order stands cancelled.
- 11. Performance Security Deposit (10% of the equipment/item/service value) will be collected from the supplier before releasing supply/purchase order. The security deposit would be returned only after expiry of the warranty period and sixty days. In the event of selected firm refusing or failing to supply the equipment, the security deposit would be forfeited. And it is also informed that the Performance Security deposit has to be claimed within three years after completion of warranty period, otherwise it would be forfeited.
- 12. **Price** should be quoted in net per unit (after breakup) and must include all packing and delivery charges to various Departments/Centers/Institutions. The offer /bid should be exclusive of taxes and duties, which will be paid by the purchaser as applicable. However the percentage of tax & duties should be clearly indicated. The price should be quoted without custom duty and excise duty, since CIBA, Chennai is exempted from payment of excise duty, and the custom duty, which will be paid at concessional rate against duty exemption certificates.

Agency commission will not be paid in foreign currency under any circumstances. The details should be explicitly shown in Tender even in the case of 'Nil' commission.
